Applications will only be processed between October 15th and November 26th. Applications received prior to October 15th will not be opened or processed or receipt confirmed until October 15th. You can send it in earlier but your check will not be processed until after October 15th.

Mandatory Meeting:

There will be a MANDATORY parade meeting Tuesday Nov 30th from 5:30 – 7:30 pm at The River House, 305 Acacia Rd, Vero Beach FL, 32963. The responsible party from your group and float drivers MUST attend. If representatives from your organization do not attend, your organization will not be allowed to participate in the parade.

Code of Conduct and Compliance Agreement:

Please initial the following items in the spaces indicated. Violations will result in immediate removal from the parade, disqualification from judging and prevention of entry in next year's parade.

___ Any motorized vehicle (with wheels and a motor) must be driven by an adult 18 years or older with a valid driver's license and insurance.

___ Every generator must have a corresponding, charged and rated fire extinguisher. Floats will be inspected for compliance at the staging area by county fire officials and will be disqualified from participation if you are non-compliant with county fire code.

___ NO ALCOHOL is permitted on the float, at the staging area or along the parade route.

___ Absolutely NO STOPPING. The parade is rain or shine and must keep moving at all times.

___ No Items may be thrown or handed out to the crowds anywhere along the parade route.

___ No Santa Costumes. He is always the last spectacular float at the end of the parade & we do not want to confuse believers like us!

___ I agree that my group will comply immediately with any Official Parade Representatives requests.

I have read, understand and agree to the parade rules and guidelines contained in the application form and information packet for the Christmas Parade. As the applicant and responsible party, I agree to be totally responsible for the safety of my entire unit and agree to indemnify and hold harmless the Treasure Coast Rotary Club, Oceanside Business Association, City of Vero Beach, and all Volunteers, Sponsors and Contributors from any and all liability, claim, demand or suit, including attorneys' fees and costs for the defense of any such claim, whether suit be actually brought or not.
